

MUNICIPALITY OF RHINELAND

BY-LAW No. 2018-2

BEING A BY-LAW to establish a ward system for the purpose of electing Municipal Council.

WHEREAS provincial regulation 135/2014 states:

**5 (4) After 2014 General Elections**

The number of councillors and the wards prescribed in this section are effective for the 2014 general election. For the following general election and after that, unless otherwise provided by by-law of the new municipality,

(a) the council of the new municipality is to be composed of a head of council and seven councillors; and


(b) each member of council is to be elected by a vote of the voters of the whole new municipality.

AND WHEREAS under section 88 of the Municipal Act, Council deems it necessary to establish the number wards and ward boundaries for the purpose of achieving representation by population;

NOW THEREFORE, Council of the Municipality of Rhineland, in meeting duly assembled, enacts as follows:

1. The three wards be established for the election of councilors in the Municipality
  - a. Ward 1 – (South East Ward) two to be elected
  - b. Ward 2 – (West Ward) two to be elected
  - c. Ward 3 – (North East Ward) two to be elected (Schedule A)
2. That this by-law takes effect at the next general election

DONE AND PASSED as a by-law of The Municipality of Rhineland at Altona, in the Province of Manitoba in Council duly assembled this 14<sup>th</sup> day of February, 2018.

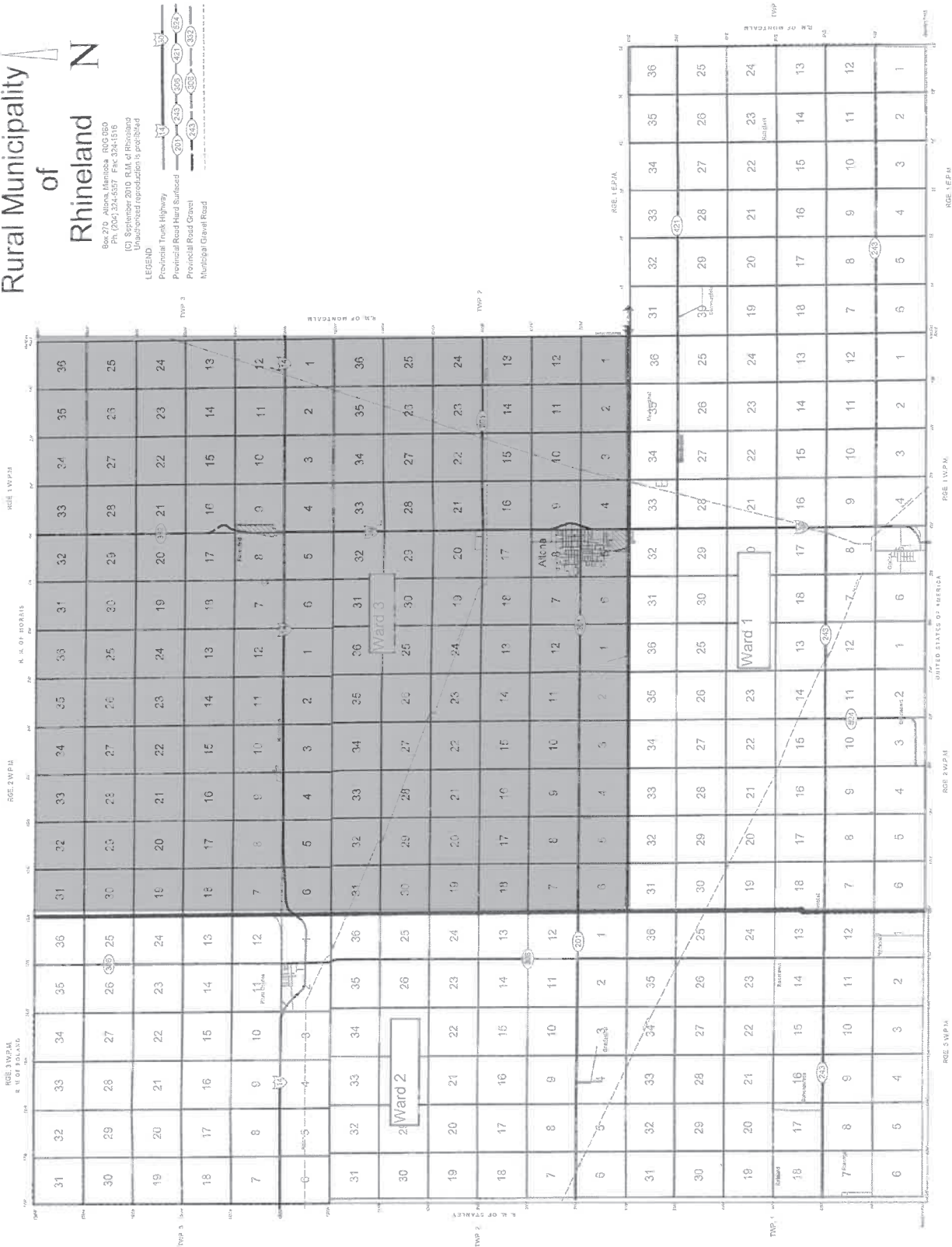
