THE MUNICIPALITY OF RHINELAND BY-LAW NO. 2015-10

BEING a by-law of the Municipality of Rhineland to regulate licensing of Lotteries within the municipality.

WHEREAS pursuant to Order-in-Council No. 524/1997 the Lieutenant-Governor-in-Council has authorized any municipality, including to license any charitable or religious organization located within its boundaries to conduct and manage a raffle lottery, as provided in paragraph 207(1)(b) of the Criminal Code of Canada, where the total prizes for each raffle lottery. Bingo lottery or lottery scheme do not exceed the value of three thousand (\$3,000.00) dollars.

NOW THEREFORE the Council of the Municipality of Rhineland enacts as follows:

- 1. Any Charitable or Religious organization located within the boundaries of the Municipality of Rhineland may be granted a license to conduct and manage a Raffle Lottery where the total prizes for each such Raffle Lottery do not exceed the value of three thousand (\$3,000.00) dollars.
- 2. Application for License as above described shall be in accordance with or shall be in the form attached hereto as Schedules "A" to this By-Law.
- 3. The License shall be in the form attached hereto as Schedule "B" to this By-Law.
- 4. The financial report of the licensee shall be in the form attached hereto as Schedule "C".
- 5. No License shall be issued to a Charitable or Religious organization where:
 - a. The organization propose to use the services of a person or organization to conduct and manage the lottery on its behalf, for a fee or other valuable consideration,
 - b. Pyramiding of games is to be permitted, or
 - c. Games of a type or kind known as razzle dazzle, roll down, three card Monte, punch board, coin table or any dice games are to be operated.
- 6. The fee for the issuing of License shall be:
 - a. RAFFLE LOTTERIES:

A License fee of one percent (1%) of the total value of prizes to be awarded.

b. BINGO LOTTERIES:

- a. Where the total value of prices to be awarded within each operation does not exceed \$500.00, a license fee not exceeding \$2.00.
- b. Where the total value of prices to be awarded within each operation exceeds \$500.00 a license fee not exceeding 1% of the total value of prizes as set out in the application.
- c. The fee for a license for a series of bingo lotteries may be charged on the same basis as (a) and (b) above.
- 7. The Council of the Municipality of Rhineland may by resolution appoint a licensing Officer who shall be charged with the responsibility for issuing License for lotteries within the Municipality of Rhineland.
- 8. That By-Law 514-85 be rescinded.
