

SPECIAL SERVICES PLAN NO. 2022 – 01 FOR

Recreation support, fire protection services, road/sidewalk repair and improvements, street lighting, and beautification

(Pursuant of Section 314 of The Municipal Act)

(a) Description of Proposed Special Service

The Municipality of Rhineland will continue to provide recreation support, fire protection services, road/sidewalk repair and improvements, street lighting, and beautification services (tree planting or control, grass and weed cutting and control) to properties within the L.U.D. of Gretna.

Council is proposing to shift the tax levy from the L.U.D. of Gretna Special Area levy to a Special Service levy to allow otherwise exempt property which also benefit from these services to be included in the tax base. This special service tax will be shown on a separate line on all tax statements and will be in place for the next 5 years (2023-2027). By-law No. 755-2005 being a Special Service levy for fire protection and street lighting services of the former Town of Gretna will be repealed with the services being include in this one.

(b) Special Service Area to be levied

The Special Service Area to be levied under this proposal, will be all taxable, grant-in-lieu and otherwise exempt property within the L.U.D. of Gretna described on schedule B attached hereto.

(c) Estimated Cost of the Special Services.

The estimated cost of the Special Service plan for the next five years is as follows with an estimated 5% increase in costs between the years:

(d) Method and Rate of Calculating the Special Services Tax

The method of taxation to be used to calculate the Special Service Tax will be by applying a special mill rate against the portioned assessment of each property. The assessed property is all ratable properties, including taxable, grant-in-lieu and otherwise exempt properties, within the L.U.D of Gretna.

The special mill rate will be determined according to the estimated cost of service and will be set in the Municipality of Rhineland annual Financial Plan to a maximum annual levy as per the estimated cost above.

Schedule "A"

Based on the 2023 assessed values of the properties (supplied by the Department of Municipal Relations) an estimated [\$219,500/ 20,991,060 x 1,000] 10.46 mills will be required. Calculated on a residential property valued at \$200,000 (portioned 90,000) an estimated \$941.40 special service tax will be levied in 2023.



REGARDING SPECIAL SERVICE PROPOSAL - BY-LAW NO. 2022-06

For recreation support, fire protection services, road/sidewalk repair and improvements, street lighting, and beautification

The Council of the Municipality of Rhineland has scheduled a public hearing at the Municipality of Rhineland Office, located at 109 3rd Avenue NE Altona, on the 16th day of November 2022 at 10:00 a.m. to present the following special service proposal:

The intent of the Special Service Plan 2022-01 is to continue providing recreation support, fire protection services, road/sidewalk repair and improvements, street lighting, and beautification within the L.U.D. of Gretna.

This special service plan will allow for currently exempt properties to be subject to taxation creating equitably between all properties receiving and paying for these services. The method of taxation to be used to calculate the Special Service Tax will be by applying a special mill rate against the portioned assessment of each property. The special mill rate will be determined according to the estimated cost of service and will be set in the Municipality of Rhineland annual Financial Plan to a maximum annual levy as per the estimated cost below:

Based on the 2023 assessed values of the properties (supplied by the Department of Municipal Relations) an estimated [\$219,500/ 20,991,060 x 1,000] 10.46 mills will be required. Calculated on a residential property valued at \$200,000 (portioned 90,000) an estimated \$941.40 special service tax will be levied in 2023.

This proposed by-law will replace the existing special service by-law 755-2005, which will be repealed.

A written objection may be filed with the Municipality of Rhineland Chief Administrative Officer, at 109 3rd Avenue, Altona, MB prior to the commencement of the hearing. At the hearing, Council will hear any potential taxpayer who wishes to make a presentation, ask questions or register an objection to the special service proposal.

All objections, written or verbal, must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection.

MUNICIPALITY OF RHINELAND

SPECIAL SERVICES BY-LAW No. 2022-06

BEING a By-law of the Municipality of Rhineland to establish a rate for recreation support, fire protection services, road/sidewalk repair and improvements, street lighting, and beautification as a special service within the L.U.D. of Gretna in the Municipality of Rhineland limits for the years 2023 to 2027, inclusive.

WHEREAS Section 312 of *The Municipal Act* of Manitoba, provides as follows:

- If approved by by-law, a municipality may provide, as special service to all or a part of a municipality, one or more of the following:
 - (a) highway construction and maintenance;
 - (b) snow removal and dust control;
 - (c) tree planting or control of a plant or tree disease;
 - (d) grass and weed cutting and control;
 - (e) recreation support services;
 - (f) street lighting;
 - (g) fire and police protection services;

AND WHEREAS Section 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- a) approve the local improvement or special service as set out in the plan or proposal; and
- b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS the Council of the Municipality of Rhineland, in the Province of Manitoba, has prepared Special Services Plan No. 2022-01 to establish a rate for recreation support, fire protection services, road/sidewalk repair and improvements, street lighting, and beautification in the L.U.D. of Gretna, as a special service pursuant to Part 10 of the Act;

AND WHEREAS the requirements as prescribed in sections 318, 319 and 320 of the Act have been complied with;

NOW THEREFORE the Municipality of Rhineland, in open council assembled enacts as follows:

- **1. THAT** pursuant to subsection 320(1) of The Municipal Act, the Municipality of Rhineland approves Special Service Plan No. 2022-01 attached hereto as Schedule "A".
- **2. THAT** the Municipality of Rhineland levy an annual special service tax upon all rateable properties, including otherwise exempt properties, within the L.U.D. of Gretna, in the Municipality of Rhineland as hereby attached in Schedule "B".
- 3. THAT the Municipality of Rhineland By-Law 755-2005 hereby be repealed.
